ACKNOWLEDGEMENT OF RISKS: ASSUMPTIONS OF RISKS AND RESPONSIBILITY; RELEASE OF LIABILITY; AND INDEMNITY AGREEMENT: ACTIVITY: Hot Rods & Harleys® 21st ANNUAL CAR SHOW

AUTHORIZATION: I hereby authorize any medical treatment deemed necessary in the event of any injury I may incur while participating in the Activity. I have either appropriate insurance, or in its absence, agree to pay all costs of rescue and/or medical services as may be incurred on my/our behalf.

RELEASE: For good and valuable consideration, I, for myself and for any of my minor children, spouse, next of kin, dependents, personal representatives, heirs, and other persons for whom I am responsible that (i) Hudson Insurance Company, the Fort Mojave Indian Tribe, DBA Avi Casino Enterprise, Inc. et al. and his, her, their or its agents, servants, successors, heirs, executors, administrators, and all other persons, firms, corporations, associations or partnerships, (ii) each and every property the activity is conducted, and his, her, their, or its agents, servants, successors, heirs, executors, administrators, and all other persons, firms, corporations, associations or partnerships (all persons and entities referenced or identified in (i), (ii), and (iii) being hereinafter individually referred to as "Releasee" and collectively referred to as "Releasees") shall have no liability of any nature for any and all injury, death, or damages to me and other persons or properties as a result of my/our participation in the activity. This release shall remain valid and binding on me/us despite any acts, omissions or negligence of the Releasee and/or Releasees, and I hereby release and discharge each and every Releasee for any injury, death or damage.

I have read and voluntarily sign the Acknowledgement of Risks, Assumptions of Risks, and Responsibility, Release of Liability and Indemnity Agreement. I understand that by signing this document, I am expressing my intent to waive legal rights, including any and all rights I may have or now have against each and every Releasee.
