SET UP: 6 a.m. Saturday (You may set up Friday after 5 p.m. strictly at your own risk, we provide NO security. If you set up in the wrong space you WILL be required to move.)

REQUIREMENTS: Artist/Crafter Booths (Space Fee - \$55.00/adults, \$40.00 for high school or younger)
Artisans and Crafters with quality items will be placed in the traditional north portion of the Courthouse Square. If this is your first time at this event, please submit photographs. Only quality items will be allowed in the northern section of the show.

Flea Market Booths (Space Fee - \$55.00/adults, \$40.00 for high school or younger)

Flea Market section is provided for non-handmade items. The committee is aware that some past participants were selling wholesale market and flea market items and passing them off as handmade. The committee would appreciate these vendors voluntarily placing themselves in the Flea Market section of the show. The Flea Market section is located on the south end of the Courthouse Square. Both sections are great and important additions to the show, however there is a definition between the artist and market vendors.

REGISTRATION: ALL SPACES MUST BE PAID FOR BY JULY 16, 2021. IF SENT AFTER THAT DATE, A \$10.00 FEE WILL BE ADDED.

- Vendors that were with us last year have their first chance at reserving your booth space from 2020 – We Will Hold Only Until 30 Days Prior to Event Date! Your booth at this time will be assigned to new vendors. We will accept booths until the show if filled. Artists are encouraged to apply early.

DISPLAY:

- All exhibitors/vendors must check the list posted on the Chamber office window after 5:00 pm on Friday, July 16, 2021, (located across the street) to find their pre-assigned space
- All spaces are approx. 10 ft. x 10 ft in size.
- Exhibitor/vendor will be responsible for creating an attractive booth, making sure to observe posted set-backs from sidewalks, and seeing that displays fit into the designated space without infringing on neighboring space. You may not spread out behind your space (if footage is available) without permission, and only reasonable requests will be allowed.
- Exhibitor responsible for setting up their booth, including tables and display materials.
- All exhibitors are encouraged to be in attendance to manage their displays. The opportunity to meet the artist and discuss work in an informal setting attracts many visitors and increases sales. Exhibitors unable to attend should select a qualified person to supervise their booth.
- All sales will be conducted between the exhibitor/vendor and purchaser, and sales tax is the responsibility of the exhibitor/vendor.
- The show committee and its sponsoring organization will not be liable for loss or damage of artwork or display materials.
- Remember, this is an OUTDOOR SHOW – All exhibitors/vendors must provide protection from the weather if necessary.

ACCEPTANCE:

When your entry form is received a confirmation notice will be forwarded by email. Additionally, you must keep the following rules in mind:

- Exhibitors/vendors must have their booth open for the duration of the show. Barriers WILL NOT BE MOVED UNTIL THE END OF THE SHOW!

- Exhibitors/vendors may park along Lake Avenue and the drive to the Courthouse for unloading ONLY—it is mandatory that your vehicle be moved elsewhere as soon as possible. The north, south and east sides of the courtyard are open for parking. ABSOLUTELY NO DRIVING ON THE COURTHOUSE LAWN!
- Exhibitors/vendors MUST observe posted SETBACKS from the sidewalk.
- FOR INSURANCE PURPOSES, NO ANIMALS ARE ALLOWED AT THIS SHOW.
- Booth area MUST be kept clean and each exhibitor is responsible for their own garbage. PLEASE MAKE CERTAIN YOUR SITE IS CLEAN BEFORE YOU LEAVE.

NOTICE to FLEA MARKET VENDORS:

• This organization will not be responsible for policing duplicate vendors. The request to do so in the past has caused undo stress and backlash toward volunteers and criticism from the very vendors who insisted that this be controlled by this organization.
